Treasurers' Report: Currently \$17,935.50 in checking

1. \$2,046.43 net income January thru September

2. Persons want dues to go to rent, not ABTB during COVID

3. Approve: Eric; second, Kathy

## Old Business:

- 1. Discussion re Alano BOD members retiring
  - a. Discussion re: term lengths (2 years)
  - b. Many long-time BOD volunteers still in their positions ("burnout")
  - c. Do we have a rule that does not allow "Snow Birds" to sit on the Board? (no)
  - d. Now meeting online- persons who wish to participate from "anywhere"
  - e. Eric is willing to continue on the Board until elections in January
  - f. Willing to continue indefinitely as Web Master volunteer
- 2. Bob would like to resign as President to become President Emeritus. Asks for new volunteer to replace him
  - a. Time to reduce responsibilities
  - b. Will discuss in next BOD meeting

#### Membership: Currently 27 members on spread sheet

- 1. Many lost members may be social causses (COVID)
- 2. Lapsed members- reasons for not paying dues
  - a. COVID attendance restrictions
  - b. Need for WestEnd rent supersedes need from ABTB
  - c. Reach out to previous BOD who no longer pay dues- why?
- 3. Do we still need COVID insert ? (read by Lynda)
  - a. Seems appropriate since we are still meeting virtually
  - b. Peg will update letter to delete refences to social functions
- 4. Reminder that dues can be paid annually or monthly (PayPal takes 2%)
  - a. Discussion re "Snowbirds" paying less than year round residents?

"If you can afford to be a Snowbird, you can afford \$100/year"

5. Dues usage for maintaining Zoom Subscription (\$150) and security for WestEnd Hopefully, a new building in the future

#### **New Business:**

  - b. Initiated as a form of fund raising (~ \$140/ year)
  - c. Now losing money- only \$4 last month

- b. Rent locked at \$1400/month x 3 years
- c. Additional \$25/month for liability insurance
- d. Document to be forwarded to BOD members for perusal and affirmation

  - i. Removed with recent renovation

  - i. Kris (Ace Hardware) has evaluated problem
  - ii. Peg will contact landlord
  - iii. May require professional??
- d. Reminder "NO DOGS" at in-person meetings
  - i. More than once lately
  - ii. Dogs ON couches!!
